EVALUATION CRITERIA

The academic performance of students is assessed on the basis of a credit-based system of evaluation. At the conclusion of each semester, students are awarded a Semester Grade Point Average (SGPA), which reflects their performance in that semester. The overall performance across the programme is represented by the Cumulative Grade Point Average (CGPA), which is calculated as the weighted average of SGPA earned over all semesters.

For the Five-Year Integrated Programmes (B.A. LL.B., B.B.A. LL.B., and B.Com. LL.B.), students are required to complete a total of 202 credits over ten semesters. The course structure assigns 4 credits to core subjects, which are evaluated through a relative grading system to ensure a fair and competitive assessment. Credit courses carry 2 credits and are evaluated through an absolute grading system, while internships carry 4 credits each and are also assessed on the basis of absolute grading.

For the Three-Year LL.B. Programme, students are required to complete a total of 132 credits across six semesters. The structure similarly provides 4 credits for core subjects, evaluated on a relative grading system, while credit (1 credit each) and internships (4 credits each) are assessed on the basis of absolute grading.

BATCH OF 2026 AND WHY KLE LAW COLLEGE

The Class of 2026 stands out for its blend of academic excellence, leadership, and community engagement. Our batch has consistently excelled in moot courts, ADR competitions, Model United Nations, parliamentary debates, publications, sports, and cultural activities, bringing recognition and laurels to the university.

Demonstrating strong leadership, many of our students hold key positions in secretariats of MUNs, moot courts, and ADR forums. Significantly, our batch revitalized several previously inactive committees such as the Cultural Committee, IPR Committee, and ADR Committee, ensuring greater student participation and institutional growth.

A key academic contribution of the Class of 2026 has been the establishment of the Jurisprudence Club, envisioned as a platform for intellectual engagement and critical discourse on contemporary legal and ethical issues. The Club successfully organized the International Conference on Ethico-Legal Dimensions of Advanced Technologies: A Pathway to Responsible Innovation on 18–19 November 2023, in collaboration with KLE Law College and the Global Academy of Law-Tech Education & Research. The conference brought together scholars, practitioners, and students to deliberate on the challenges posed by emerging technologies such as blockchain, artificial intelligence, the metaverse, fintech, and robotics, and their implications for human rights, intellectual property, privacy, data protection, and cybersecurity. This initiative not only enriched the academic environment of the university but also positioned it as a hub for thought leadership in law and technology.

Equally significant has been the revival of the Commerce and Management Committee, which the batch strengthened through its flagship event, Vanijya Nagari. Organized across four successful editions, the event fostered entrepreneurial thinking by enabling students to develop business ideas, set up stalls, and showcase products, services, and innovations. By combining creativity with practical management skills, the initiative reflected the dynamic and versatile spirit of the Class of 2026.



Research Culture & Achievements



KLE Law College, Bengaluru—a constituent of KLE Technological University—has built a strong research ecosystem by integrating structured research practices into both faculty and student development. Faculty are categorized as Young Faculty Researchers, Evolving Research Scholars, Evolving Research Guides, and Senior Research Guides, and are grouped into departmental research clusters that promote mentorship, collaboration, and thematic alignment. For students, the College offers the Research Experience for Undergraduates (REU) programme, enabling credit-earning guided research, training in research methodology, and opportunities to publish in reputed journals indexed in SCOPUS, Web of Science, and CARE.

To further strengthen research culture, the College sponsors student-faculty participation in seminars and conferences, offering financial support for jointly authored papers. It also hosts two annual national conferences—one on Constitutional Law and another on Information Technology Law—successfully completing its 10th edition. Through these initiatives, KLE Law College continues to nurture inquiry-driven learning and sustain an environment of academic rigor, innovation, and meaningful dialogue on contemporary legal issues.

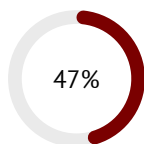

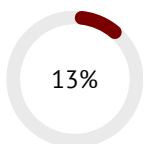
Mooting Culture & Key Achievements by Batch of 2026

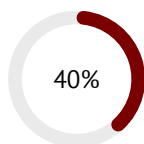

Students of KLE Law College have secured internships across premier national law firms, senior advocates' chambers, High Courts, the Supreme Court, corporate legal departments, and PSUs. These engagements reflect the institution's strong professional networks and rigorous training ecosystem.



1 PRE-PLACEMENT TALKS

- The company delivers a pre-placement talk (online/offline) explaining its profile, role, salary structure, job location and other terms to all registered/applying students.
- Attendance is mandatory, and students are expected to use this stage to clarify doubts about the job profile, salary break-up, place of work and contract details.

3 PRE-INTERVIEW SCREENING PROCESS

- Students choose to apply to specific companies after checking eligibility, role and CTC, and once opted in they are not allowed to withdraw after any screening round unless not shortlisted.
- Companies may conduct initial shortlisting via aptitude tests, group discussions or other written/screening rounds to filter candidates for further interviews.

2 COORDINATION & LOGISTICS

- The recruiter first submits a Job Notification Form with job description, CTC and location to the Placement Committee, which then circulates the details.
- Eligible students register with the Placement Committee, submit CVs in the prescribed format with proof, follow notified deadlines, dress code and reporting time, and all communication/offers flow only through authorised placement officials.

4 INTERVIEW PROCESS AND RESULTS

- Shortlisted students attend all remaining rounds such as personal/technical/HR interviews, including any final interview at the company office if required.
- From those who completed all rounds, the company prepares the final selection list, shares it with the Placement Committee, sends offer letters through the Committee, and students then accept by signing and returning the offer/acceptance letter; the one-person-one-job rule applies after an offer is received.

RECRUITMENT PROCESS

Campus recruitment at the college follows a structured and transparent process, beginning with companies sharing detailed job profiles and engaging students through pre-placement talks to explain roles, compensation and career growth. The Placement Committee centrally coordinates registrations, applications and all communication, while companies conduct their own tests and interviews to evaluate candidates before sharing final results and offers through the college, in line with a fair, one-student-one-offer policy.

Placement & Guidance Cell

MENTOR is the Career Guidance Cell of K.L.E. Society's Law College, Bengaluru. It has been instrumental in training students and providing job opportunities in leading law firms, multinational corporations, non-governmental organizations, banks, educational institutions, non-governmental organizations and the like. MENTOR plays a pivotal role in providing career guidance to its students. It conducts various activities and workshops such as contract drafting training, professional ethics training, group discussions, and mock interviews for the students.

The Placement Committee is a wing of Mentor. It shoulders the responsibility of coordinating all the aspects of recruitments and placements at K.L.E Society's Law College. The Placement Committee is an organ of the Mentor Cell. It makes sure that the students have ample opportunities for internship and jobs in law firms, LPOs, advocates, and companies. The placement Committee draws up the database of students, invites recruiters from over the country for on and off campus placements and organizes pre-placement talks. The committee functions throughout the year to coordinate the activities so that the placement drive each year becomes a huge success.
